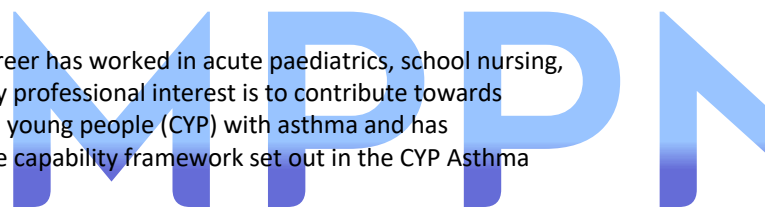

### SPEAKERS – VIV MARSH (RGN, RSCN, SCPHN, Independent Prescriber, Queen’s Nurse)

Viv is an asthma nurse specialist and the Clinical Lead for Children and Young People’s Asthma Transformation in the Black Country ICB.

She became a registered nurse in 1991 and throughout her career has worked in acute paediatrics, school nursing, specialist nursing, clinical education and research. Her primary professional interest is to contribute towards improving quality of life and clinical outcomes for children and young people (CYP) with asthma and has collaborated with NHS England around the development of the capability framework set out in the CYP Asthma



national bundle of care. Viv is responsible for the implementation of the national bundle of asthma care in the Black Country.

In her research role Viv works with general practice teams across the UK to implement the IMP<sup>2</sup>ART research trial strategy to improve supported self-management of asthma in routine primary care practice. In 2024 she became the CYP Lead for the Association of Respiratory Nurses, and Viv is also a member of the Asthma + Lung UK Council of Healthcare Professionals and the Lead Asthma Tutor for Rotherham Respiratory.

## NAZIR HUSSAIN

Nazir is a Specialist Respiratory Pharmacist at Dudley Integrated Health & Care NHS Trust, leading one of the largest primary care pharmacy teams in the country.

In 2011, Nazir was accredited by the Royal Pharmaceutical Society of Great Britain as a Pharmacist with a Special Interest in Respiratory Care (PhwSI), one of the first pharmacists to do so in primary care. In 2023, he won the 2023 PCPA General Practice Pharmacist of the Year award in recognition of his work establishing an innovative specialist pharmacist respiratory clinic in Dudley for the diagnosis and management of asthma and COPD. Nazir is also central to several other innovative asthma projects including the West Midlands Academic Health Science Network FENO project, restoration of spirometry in primary care quality improvement scheme and identification of suspected severe asthma (SPECTRA).

Nazir also sits on the Black Country Respiratory Subgroup and on the Early and Accurate Diagnosis Task Group for Children and Young People across the West Midlands ICS.
